Act started in 1992 (limits were same as 1996) but not enough public funding until the 1996 election (every office was covered). Due to limited funds, a tiered system was developed and for the 1998 election, only the Legislature was covered. Since election year 2000 every office has been covered except for Governor (approximately \$910,000 required in fund for Governor to be covered). "Contribution Limit" is for contributions from PAC's, Parties, Businesses, etc. and is an aggregate total for the election period. The CFLA was invalidated by the Nebraska State Supreme Court in 2012.
