Beginning on the 11<sup>th</sup> day an additional daily late fee of 1% of the amount to be disclosed by the report is assessed, not to exceed 10%.**

## General Information - Filing Requirements

### A. Who Should File:

Any political committee receiving a late contribution. A late contribution means a contribution of \$1,000 or more which is received during the 14 days immediately preceding an election (i.e., after the closing date of the last Campaign Statement required to be filed prior to an election).

### B. When to File

File within 2 days after receiving the contribution.

A Report of Late Contribution is filed on time if it is postmarked by the U.S. Postal Service or personally delivered on or before the due date. If the due date falls on a weekend or state holiday, the filing is due the next business day. **Late filing fees are \$200 per day for each of the first 10 days the report remains not filed. Beginning on the 11<sup>th</sup> day an additional daily late fee of 1% of the amount to be disclosed by the report is assessed, not to exceed 10%.**

### C. Where to File:

File with the Nebraska Accountability & Disclosure Commission. Reports of Late Contribution may be faxed to the Commission office at 402-471-6599. The filer may call the Commission to confirm the fax has been received. It is the responsibility of the filer to insure that fax transmissions are received by the Commission.

NOTE: All late contributions must also be reported on the committee's post-election Campaign Statement.

Statutory Authority: Section 49-1458, Revised Statutes of Nebraska.
