### INFORMATION FOR ELECTION OFFICIALS

#### INELIGIBLE CANDIDATES-CIVIL PENALTIES OWED

Last Updated: November 18, 2025

Candidates Ineligible- Individuals who owe civil penalties and/or interest on civil penalties assessed by the Nebraska Accountability and Disclosure Commission **are not eligible to file for public office**. See §49-14,142; §32-602 and §32-607 of the Revised Nebraska Statutes for details of this provision and exceptions.

The following individuals owe the State of Nebraska civil penalties assessed by the Nebraska Accountability and Disclosure Commission and/or interest on a civil penalty. The county of residence of the individual on the date of the assessment is also shown.

### STATEMENTS OF FINANCIAL INTERESTS FILED BY CANDIDATES

Candidates for certain public offices are required to file a Statement of Financial Interests as part of the process of having their names appear on the ballot.

Who Must File: In 2026, Statements of Financial Interests must be filed by candidates for:

1. Governor, Lieutenant Governor, Secretary of State, Attorney General, Auditor of Public Accounts, State Treasurer.
2. Member of the State Board of Education, member of the Board of Regents of the University of Nebraska and member of the Public Service Commission.
3. Member of the Legislature.

4. Any county elective office.
5. Member of the board of directors of a district organized under Chapter 70 of the state statutes including a public power district, a rural public power district and a public power and irrigation district.

To determine if a candidate has filed, please click the following link [Statements of Financial Interests \(Form C-1\)](#) and do the following:

1. Next to "Filing Year" click on "2025"
2. Type the last name of the candidate in the "Last Name" box
3. Skip down to the Search/Reset boxes and click on "Search"

**OR** go to <https://nadc-e.nebraska.gov> and do the following:

1. At the top of the page, click on the "Search" tab
2. On the drop down, click on "[Statements of Financial Interests \(C-1\)](#)"
3. Next to "Filing Year" click on "2025"
4. Type the last name of the candidate in the "Last Name" box
5. Skip down to the Search/Reset boxes and click on "Search"

A list of all filers including that last name will be displayed by name and date of filing. If you see the name you are seeking, you may click on [View](#) to see the filing. If [View](#) does not appear next to their name or if the name of the candidate you are seeking does not appear, then a person by that name has not filed a statement for 2025. **Be sure the candidate has filed a statement covering 2025.**

Things to know about Statements of Financial Interests:

- Item 5 on the form shows the period covered.
- A candidate filing to appear on the 2026 ballot must file a Statement of Financial Interests covering the year 2025.

Statements of Financial Interests are **due on or before March 2, 2026**. There is a statutory grace period which extends the deadline to March 9, 2026. A filing which is legibly postmarked by the U.S. Postal Service on or before the deadline is considered on time.
